AN INDEX TO VOLUMES I - XXX/XXXI

In 1969 the Dutch Archaeological and Historical Society first published its periodical *TALANTA*, which has appeared since on regular intervals. On the occasion of the 30th-31st volume, exactly 30 years after the instalment of the Proceedings of this Society, it seemed appropriate to offer our readership an index. The emphasis of the periodical's contents has always been on the combination of archaeology and ancient history. It has always tried to reach a readership of both scholars and dilettanti. With 86 authors contributing 168 articles on a broad range of subjects, *TALANTA* has met these intentions very well.

The index is divided in a chronological one, listing the contents of the individual volumes as they appeared in *TALANTA* 1 to 30/31, and a thematic one, listing the articles by subject-matter (the subjects are listed alphabetically). In a last index the authors follow in alphabetical order, according to their surname.
